

POST 16 EDUCATION PROVIDER ACCESS POLICY

This policy statement sets out the school's arrangement for managing the access of Post 16 provider visits to Saint Martin's Catholic Academy. The purpose is to give information about the provider's education or training offer to the students in Year 8 to 11. This complies with the school's legal obligations under Section 42B of the Education Act 1997.

Student Entitlement

All students in Years 8-11 are entitled:

- To find out about technical education qualifications and apprenticeships opportunities, as part of a careers programme which provides information on the full range of education and training options available at each transition point.
- To hear from a range of local providers about the opportunities they offer, including technical education and apprenticeships through options events, assemblies, group discussions and taster events.
- To understand how to make applications for the full range of academic and technical courses.

For students of compulsory school age, these encounters* are mandatory and there will be a minimum of two encounters for students in year 8 to 9 and two encounters for students in year 10 to 11.

These post 16 provider encounters will be scheduled during the main school hours and the visitor will be given a reasonable amount of time to, as a minimum:

- Share information about both the provider and the approved technical education qualification and apprenticeships that the provider offers
- Explain what career routes those options could lead to
- Provide insights into what it might be like to learn or train with that provider (including the opportunity to meet staff and students from the provider)
- Answer questions from students
